

Report from the Chair of Pilling Parish Council

Since the last newsletter, councillors Judy Judkins and Sarah Collinge have resigned their positions, and I would like to take this opportunity to thank them for their time and efforts on behalf of our community. The vacancies were subsequently advertised and with only two people offering their service, both Lisa Stanger and Liz Kiersey have been co-opted onto the council.



Also, there has been a change of regime at Lancashire County Council with Reform now in a majority. No doubt they will have different priorities to their predecessors; however we will continue to challenge them to fulfil their responsibilities to Pilling, particularly regarding the poor state of the roads. It will also help our efforts if residents keep the pressure up by reporting defective road surfaces and pot holes on 'Love Clean Streets'.

As people will have seen, work has started to replace the doors on the outfall of the Broadfleet. This work is being carried out by contractors on behalf of the Environment Agency and is a direct result of the work and efforts of Councillors Alf Whiteside and Steve Philpotts. In addition, a group has been formed by David Wilkinson called the Broadfleet Outfall Farmer Flood Action Group to tackle these issues in the future.

In the run up to the Service of Remembrance, the Parish Council have bought some large Remembrance Poppies and three metal silhouettes which will be displayed around the village prior to the event on Sunday 9th November.



Report from the Chair of Pilling Parish Council

With regard to planning, there is good news in relation to the proposed application regarding the Preesall Quarry site. Lancashire County Council have now rejected the plans and credit must go to the committee who opposed it with the support of their district councillor, LCC councillor and our MP.

We are also continuing to press Wyre Borough Council to take action against a number of illegal developments within the parish and await their reply.

The Police Community Support Officers who cover Pilling are aiming to hold regular 'Drop-In' sessions at the Village Hall to meet our community and listen to your concerns. These will be on a Thursday lunch time - the exact dates are to be confirmed and will be displayed on the 'In The Know' messaging service which can be accessed via the Lancashire Constabulary web site.

Lastly the cover for this edition of the Newsletter was designed by Olivia Briggs who is a year 2 pupil at St Williams Catholic Primary School. Congratulations goes to Olivia who received a £20 book token for her endeavours.



As Christmas is just round the corner, may I take this opportunity to wish you all a happy, peaceful Christmas and a joyful New Year.

Update: St Williamsgate/Create Homes

This matter unfortunately continues to drag on. The Planning Department at Wyre Borough Council received a discharge notice in July regarding the vacant plot originally earmarked for affordable housing. It is understood the Council have accepted that there are no social housing landlords/associations who are interested in this location and are, therefore, looking at the discharge notice.

The Parish Council have been informed that planning have requested further information of the qualifying persons. The Parish Council have requested what this additional information is and who from (Create Homes or their planning consultants DePol Associates) and how, as a Parish Council, we can assist the process.

At this time there has been no reply from the Planning Department.

This is hugely frustrating for the residents and the Parish Council will continue to press both the Planning Department and the developers for information on their proposals, progress and time frames for completion.

Broadfleet Outfall Farmers Flood Action Group

Over the last year, Pilling Parish Council have raised the awareness of the flooding issues in Pilling and the surrounding parishes. Following this, a group has now been set up, led by the farming community, under the title "Broadfleet Outfall Farmers Flood Action Group" to tackle these issues.

We believe the main issues are:

- Regular maintenance of the Dyke network
- Lobbying for better gates or pumps through the sea wall
- Clearing and maintaining a channel through the Salt Marsh out to Lune Deeps

Whilst all this work used to be carried out by the Environment Agency it has become obvious over the last decade that they are no longer have the necessary funding. The Group will work with the EA and other bodies such as Natural England to apply for the necessary licenses and for funding to carry major works out.

One recent success is the fitting of new flood gates on the Broadfleet Outfall which for the last 12 months have been allowing sea water in on big tides causing the dykes to flow the wrong way for up to a mile inland. Following lobbying by the group the EA are now fitting the gates which should be up and running by the end of the month.





The group, which has a fully constituted committee has a membership of around 40, mainly farmers, but is open to anyone with an interest in the flooding issues. Membership fee is a nominal £10. The more members we have the more lobbying power we will have. Anyone interested is welcome to give me a call.

One of the main problems causing flooding issues is the clearing of the dykes and watercourses within the area.

The following picture shows what a difference is being made by the dykes being cleared, with the water able to drain off the fields and flow out to the sea, but this can only be successful if everyone who has a watercourse within their boundaries fulfils their responsibilities as a riparian landowner.




WHEN ARE LANDOWNERS AND HOMEOWNERS RESPONSIBLE FOR A WATERCOURSE?

- When part of a watercourse runs across your land you own the full stretch of the watercourse that lies within your property boundary.
- When a watercourse forms the boundary of your property, it's presumed that you own that section of the watercourse up to its middle and the adjacent landowner will be responsible for the other side up to its middle (unless it's known to be owned by someone else). It's important to check your deeds.
- When the watercourse is culverted and running through your land you own the full stretch of the watercourse that lies within your property boundary.


You may not be aware that a culvert that lies beneath your property as it may have been buried for a long time. The Land Drainage Act 1991 states that the owner of land through which a culvert passes is 'responsible for maintaining the culvert to allow for the free passage of water, whether or not he is aware of the culvert'. If you are unsure about your ownership, you can check your title deeds on the land registry.

As a riparian owner your responsibilities include:

- Maintaining the bed and banks of the watercourse, this includes trees and shrubs on the banks and also fallen trees and debris in the watercourse which may reduce flow.
- Accepting the flow of water through your land even if caused by inadequate capacity downstream.
- Allowing free passage for fish.
- Keeping your section of watercourse free from pollution and obstructions and free flowing. You shouldn't discharge chemicals, wastewater or green waste onto the banks or into the watercourse. Landowners should also use land management techniques which prevent runoff containing topsoil from entering the watercourse.
- Keep structures within the watercourse such as trash screens and culverts free from blockages. You should contact your local Risk Management Authority (RMA) for advice about maintenance and repairs.
- Control the migration of invasive species to other landowner's property.
- Not damaging local wildlife habitats, Sites of Special Scientific Interest, Special Protection Areas, Special Areas of Conservation, protected species.
- Reporting incidents of flooding and pollution.

Free NHS Health Checks in Pilling



17th January (10am - 4pm) Pilling Village Hall

The NHS Health Checks Lancashire team are heading to Pilling Village Hall!

As we get older, we are all at higher risk of developing certain health conditions such as high blood pressure, heart disease or type 2 diabetes.



Even if someone is feeling well a free NHS Health Check is a simple way to spot the early warning signs so they can take action to improve their health.

Who's eligible?

Anyone aged 40-74 who lives or works within the Lancashire County Council area and does not have certain pre-existing conditions (check the website for more details).



What is an NHS Health Check?

An appointment takes ~ 30 minutes and includes checks for:

- Height and weight
- Blood Pressure
- Cholesterol
- Blood sugar
- Basic questions about your family history, exercise, alcohol and smoking

Results are shared with your GP and where appropriate the team will refer onto a range of lifestyle services.

Local Government Reorganisation in Wyre: Update

From November 2025 - Detailed proposals from all 15 councils in Lancashire are due to be submitted by 28th November. Once this has happened, there will be public consultations giving residents a chance to input their preferred option.

Government decision is expected to select preferred proposals by mid 2026. If approved, the new unitary councils would come into effect on 1st April 2028. Shadow authorities (preparatory councils) may be elected in May 2027.

Wyre could be combined with other districts such as Fylde, Black-pool or Lancaster depending on which model is chosen. It is expected that each unitary authorities will cover a population of up to 500,000.

Postal Votes

Postal voters are now required to renew their postal vote application every three years. If you applied for a postal vote before 31 October 2023, your postal vote will automatically expire on 31 January 2026.

Food Waste Recycling

From Monday 6 April 2026, Wyre Council will be introducing a new food waste collection service.
